Quick disposal of disciplinary cases under Rule 7 of Haryana Civil Subject: Services (Punishment & Appeal) Rules, 2016.

As you are aware disciplinary matters are governed by Haryana Civil Service (Punishment & Appeal) Rules, 2016. Instructions have been issued by Government from time to time to all Departments for disposal of disciplinary proceedings under Rule 7 i.e. major penalty within a period of six months.

- However, it has been observed by Government that many such cases of disciplinary proceedings under Rule 7 have not been finalized by the punishing authorities due to inordinate delay in submission of inquiry reports by the Inquiry Officers. So, as to ensure timely disposal of disciplinary cases, particularly pertaining to the Gazetted Officers of Group A & B, Government has decided that all Administrative Secretaries shall ensure that regular inquiries pending against Gazetted Officers are finalised before the 30<sup>th</sup> November, 2021 positively.
- In such cases where an Inquiry Officer is unable to submit the inquiry report by 30th November, 2021, the Administrative Secretaries concerned shall submit a report to the Chief Secretary to Government, Haryana (in General Services-I Branch) by 07th December, 2021 mentioning the causes of delay in the finalization of disciplinary Wherever Administrative Secretary/Punishing Authority concerned is of the view that justification exists to grant more time to the Inquiry Officer to finalize the inquiry report, reasons thereof may be mentioned in the report. However, if the Administrative Secretary/Punishing Authority is of the view that there has been an unjustified delay by the Inquiry Officer in concluding the inquiry, he may initiate/propose deterrent disciplinary action against the Inquiry Officer (if he is in service) and reassign the Inquiry to some other Inquiry Officer (in case of Inquiry Officer being a retired govt. official).
- All Administrative Secretaries/Punishing Authorities shall also carry out an immediate review of the progress of disposal of regular inquiries under Rule 7 and 8 pending against the employees of Group C & D.
- It has also been decided by the Government to direct all the Administrative Secretaries/ Punishing Authorities to send information regarding cases of disciplinary proceedings/departmental inquiries pending against Gazetted Officers of Group A & B to the Chief Secretary to Government, Haryana (in General Services-I Branch) both in the shape of soft copy by email at <a href="mailto:generalservices0001@gmail.com">generalservices0001@gmail.com</a> and also by way of hard copy positively by 05th of October, 2021 in the following format:
