2. These promotions are without prejudice to the disciplinary proceedings pending against his/her seniors. If their senior is found eligible for promotion at any subsequent stage, these promoted employees will be reverted back to their parent post at that stage.
3. These promotions are further subject to Government Court decision adversely affecting his/ her promotion.
4. In case the vacancy against which he/she is being promoted ceases to exist and there is no vacancy for the post on which he/she is being promoted. He/she will be reverted to his/her original post without any notice.
5. He/ she will remain on probation for a period of one year, which can be extended in terms of service Rules.
6. In case he/ she does not join the promotional post within 15 days, his/her promotion will stand cancelled.

7. The promotion orders are subject to the modification/correction in case of any discrepancy/gap that may be found at later stage.
8. If any official is found senior to his/her at any stage due to re-fixation of seniority, these officials will be reverted without giving any notice.
9. The promotion of the above officials are subject to the final decision of the Hon'ble Supreme Court in SLP No. 31566 of 2018 and other connected SLP.
10. The promotion of the above officials are subject to verification of their certificates from the concerned Boards and if any one's certificates is found fake/invalid, in that case the promotion of the concerned employee will be considered as null and void.
