HSSC/Confd./CA-14/CET-Group-C/2024/663 dated 19.10.2024, you are hereby appointed as Assistant on temporary/provisional basis in the office of Director Higher Education Haryana Panchkula w.e.f. the date you join duties in the grade pay Level-6 of Haryana Civil Services (Revised Pay) Rules, 2016 (having initial 1st Cell of Rs. 35,400) (Pre-revised PB-I, 9300-34800+4200 Grade Pay) and such allowances as admissible by the Haryana Government from time to time on the following terms and conditions:-

- You are appointed purely on temporarily/provisional basis.
- Your appointment is against temporary post and your confirmation against substantive post shall be considered on the basis of your seniority and record of service as and when such post is available.
