Subject:- Observance of 27th Road Safety Week from 10th to 16th January, 2016.

I have been directed to invite your attention on the subject cited above and to say that it is really very unfortunate that over one lakh persons lose their lives every year in our country in road accidents, causing loss of human lives, property and trauma to the family of deceased. This underlines the urgency for adopting various road safety measures. As a part of the advocaey campaign for road safety, "Road Safety Week" is observed throughout the country every year in the month of January in order to highlight and emphasize the need for safe roads. It is also an opportunity for all stakeholders to contribute to the cause by taking up activities to promote the concept.

The Ministry of Road Transport & Highways, Government of India, have decided to observe the 27th Road Safety Week from 10th to 16th January, 2016. The theme for this year's Road Safety week is "Road Safety - Time for action".

An indicative list of road safety activities which may be undertaken during the week is as under:-

1. Circulars to all employees in the Ministry and in subordinate offices and organizations for observing the Rules of road regulation- 1989 during the week and thereafter.
2. Display of Flex banner, poster at entry/exit of building, parking lots etc. notifying the week and displaying the theme.
3. Workshops, discussions, essay competition, Quiz contests etc. on the issues related to road safety i.e. effects of violation of road safety rules, rules of road regulation-1989and other Motor Vehicle regulations.

4. Organization of medical camps for check-up of drivers.
5. Organizing refresher training for drivers by imparting training about road safety rules, various sign/ signages and first aid service in case of accident.
6. Informing drivers and other Ministerial employees about the Supreme Court's verdict wherein it has been specified that "The effort to save the person should be the top priority not only of the medical professional but even of the police or any other citizen who happens to be connected with that matter or who happens to notice such an incident or a situation" and There is no legal impediment for a medical professional when he is called upon or requested to attend to an injured person needing his medical assistance immediately".
7. Fitness check up of all the vehicles in the Ministry and attached organizations.

In order to carry out these activities in a befitting manner, you are, therefore, requested that involvement of all the concerned agencies like Traffic Police, Health, Information & Publicity, Education, PWD, Local Bodies and other field agencies like Transport Authorities, District Authorities, Voluntary Organizations etc. may be ensured. All stakeholders and the public at large may be encouraged to participate. It is also requested to send an Action Taken Report in this regard by 20.01.2016 positively so that the Ministry may be apprised accordingly.
