



I have been directed to inform you that all the department of the State that Hon'ble High Court as directed the official respondents to pass speaking order or decide claim within the stipulated period of time as directed in that particular case, if the same is not complied within the time frame, and the petitioner(S) is forced to file the contempt petition before the Hon'ble High Court, in that eventuality the Hon'ble Court while issuing notice of motion on the very first date, will impose Rs. 10,000/- as cost on the person/official concerned and that cost will be recovered from the personal pocket of the concerned official. That Hon'ble Court has granted the concession only for the first week of July 2024 and this order will be applicable from 8<sup>th</sup> July 2024. A copy of order is enclosed.
