- 4. In case the vacancy against which he/she is being promoted ceases to exist and there is no vacancy of the post on which he/she is being promoted. He/she will be reverted to his/her original post without any notice.
- 5. He/ she will remain on probation for a period of one year, which can be extended in terms of service Rules.
- 6. In case he/ she does not join the promotional post with in 15 days,his/her promotion will stand cancelled.
- 7. The promotion orders are subject to the modification /correction in case of any discrepancy/gap that may be found at later stage.
- 8. If any official is found senior to his/her at any stage due to re-fixation of seniority, these officials will be reverted without giving any notice.
