In continuation of this office letter bearing No.7/79-2017 C-IV (3) dated 05.01.2022 on the subject cited above.

It is hereby informed that State Govt. has adopted the UGC Regulation 2018 circulated vide letter bearing No. 7/79-2017 C-IV dated 11.11.2022 after the concurrence of Finance Department, Haryana.

Further, it is again clarified that on the basis of UGC clarification dated 28.07.2021, State notification dated 11.11.2022 and Departmental clarification dated 05.01.2022, one notional increment in case of promotion under Career Advancement Scheme (CAS) from lower grade pay (Academic Level Pay) to higher grade pay (Academic Level Pay) be also granted to teachers (Assistant Professor (Senior/Selection Grade), Associate Professor and Professors) of Universities and Colleges.
